

**Rule 7007-3      Oral Argument, Hearing on Adversary Proceeding**

**Motions.** No hearing will be scheduled on motions filed in adversary proceedings, unless the Court orders otherwise, except for discovery-related motions which shall be governed by Local Rule 9006-1(b). An application to the Court for oral argument on a motion shall be in writing and shall be filed with the Court and served on counsel for all parties in the proceeding no later than seven (7) days after service of the reply brief. An application for oral argument may be granted or denied at the discretion of the Court.
